# The Netherlands Film Production Incentive offers:

- up to 35% cash rebate for film productions
- 30 % cash rebate for high-end TV series

### What is eligible for funding?

The Netherlands Film Production Incentive supports the (co) production of cinematic feature films, feature-length documentaries and feature-length animated films and high-end TV drama, documentary and animation series, or single episodes. An application can be made for international and domestic (co)productions to obtain cash rebate on eligible production costs directly spent on parties subject to Dutch taxation in the Netherlands.

#### How to access

- A production company that has operated consistently in the area of production and the exploitation of film productions for at least two years prior to the application, aimed primarily at cinema release in the Netherlands, another EU/EEA member state, or Switzerland.
- The production company that receives the cash rebate must be based in the Netherlands and is legally represented by a producer who, as majority partner, has been responsible for at least 2 film productions (reference films) over the past 7 years that have been theatrically released in the Netherlands.
- This also applies in the case of an application for a series or single episode, with the proviso that the applicant/responsible producer has produced 2 reference films as mentioned above, or 2 TV series distributed by Dutch broadcasters or on VoD platforms publicly accessible in the Netherlands.

## How much cash rebate can be applied for?

- The maximum grant is € 1.5 million per film production or TV series and is determined by the production costs that are both eligible and demonstrably spent on parties that are subject to Dutch taxation multiplied by a 30% cash rebate.
- For international coproductions a cash rebate of 35% can be obtained if at least 75% of the digital production costs for a feature film are spent on parties subject to Dutch taxation and 25% in the case of a feature-length documentary or feature-length animated film (10% is sufficient for a Dutch minority co-produced feature-length animated film).
- A 35% cash rebate can also be obtained if no other Dutch state aid is part of the financing of the film production.

**Eligible production expenses** directly related to the production process are taken into account for the calculation of the rebate from the **date of application** onwards.

For film productions **30% advance payment** of the contribution is possible, following conclusion of the production agreement with the Fund. Furthermore, two interim payments are based on actual spend.

Even after shooting has been completed it is possible to apply for a cash rebate to cover post-production activities.
